## Entry requirements

Photographs should capture the essence of each Country: its people, its landscapes, its history, its architecture, its events, its traditions, and its folklore.

## Entries

1. Open to photographers, worldwide.
2. Theme – open.
3. Contest is composed of two sections:
  - A. Panoramic Format**  
Size requirements:  
A relationship of 1:3 to 1:7; minimal size on the short size of the image - 30cm.
  - B. Traditional Format**  
Size requirements:  
A relationship of 2:3, that is 30x45cm and 40x60cm, other sizes accepted, keeping in mind that the minimum measurements of the short side must be 30cm and the maximum length of the long side 60cm.

Each entrant may submit a maximum of four images per section.
4. Entries will only be accepted on CD's and DVD's, in jpg format, 300dpi, no compression, with measurements adhering to the size requirements of **3A** and **3B**. A completed entry form must be submitted with each CD or DVD.
5. Images must be borderless, no margins or frames.
6. Each entry must be written either in English or in French.  
Each entry must have an identification number, name, surname, title and country:  
1\_name\_surname\_title\_country.  
Entries in the Panorama section must add "**P**" to the identification number:  
1**P**\_name\_surname\_title\_country.

## Entry Fees

7. Fees for foreign entries:
  - \$25/20euros for one section;
  - \$40/30euros for both sections.
